2. The Terms of Reference (ToRs) of the Committee are as under:


- i. To ensure the smooth implementation of energy projects currently underway or in the pipeline, in particular projects falling under the umbrella of the China-Pakistan Economic Corridor, well within timelines stipulated for these projects;
- ii. Identify and remove bottlenecks in the expeditious implementation of these projects;
- iii. Identify the flaws and deficiencies of the existing legal and institutional framework governing the energy sector and formulate reform initiatives;

- iv. Review the current energy policy and remove its weaknesses;
- v. Formulation of policies/plans on energy conservation and regular/periodical monitoring of such policies/plans;
- vi. Conduct inter-ministerial coordination whenever required, but at least once every fortnight;
- vii. Ensure adequate stocks of POL products in the country through policy/administrative measures;
- viii. Develop efficient energy markets through deregulation within limits allowed by regulators; and,
- ix. Reduce theft losses in energy sector and to pass on benefits to consumer.


3. In the absence of the Prime Minister, Minister for Petroleum shall Chair the meeting of Cabinet Committee on Energy (CCoE).
