Subject:- AUTHORIZATION OF CELLULAR/MOBILE TELEPHONE FACILITY TO MEMBERS OF NATIONAL SECURITY COUNCIL, MEMBERS OF THE CABINET AND SENIOR OFFICIALS.

My dear Secretary/Additional Secretary Incharge,

The competent authority has been pleased to approve the use of a cellular/mobile telephone facility at Government expense for the officials listed in Annexure-I. The facility will be subject to the following conditions:-

- i. In future, permission for cellular/mobile telephones will be allowed by the Cabinet Division in consultation with the Finance Division.
- ii. The Cabinet Division in consultation with the National Telecommunications Corporation will arrange the most economical package from one of the cellular companies operating in Pakistan for provision of mobile phones. The approved package will be circulated in due course.
- iii. The monthly expenditure on a mobile phone inclusive of line rent, local/overseas official calls and other charges will not exceed Rs.4000/-. Any expenditure beyond the ceiling will be borne by the official himself and settled every month.
- iv. The expenditure on this account will be borne by the Ministry/Division through their existing budget allocations and no supplementary grant/reappropriation will be allowed for this purpose.
