Please refer to the above subject. Presently, following matters relating to the telephone policy are being dealt by the Cabinet Division in consultation with the Finance Division.

1. Installation of Telephone Connections in respect of BPS-16 and below in offices.
2. Conversion of office telephone Connections in respect of BPS-17/18 from Non-STD to STD.
3. Installation of STD Telephone Connections for Fax use at office and residence.
4. Installation of more than one Telephone connections at one premises in the offices.
5. Cases for grant of mobile Telephone Connections.
6. Cases for ISD Telephone Connections.

2. Since many cases received from various Ministries/Divisions are pending, it is proposed that a Committee may be constituted comprising Additional Secretary (EC&R), Cabinet Division and the Additional Secretary (Expenditure), Finance Division, Islamabad in order to review and decide such cases.

3. It is requested that agreement of the Finance Division to the above mentioned proposal may please be conveyed to this Division so that further necessary action be taken in this regard.
